Online Applications are invited from the intending eligible candidates for appearing in the Dibrugarh University Post Graduate Entrance Test (DUPGET), 2023 for admission to the following academic Programmes conducted by Dibrugarh University and its Affiliated and Autonomous Colleges in the Academic Session 2023- 2024:

2.	<b>Master of Science (M.Sc.):</b> Anthropology, Applied Geology, Chemistry, Geography, Life Sciences, Mathematics, Physics and Statistics	Bachelor's Degree with Major/ Honours in the concerned subject securing at least 45% marks or equivalent grade point. OR Bachelor's Degree with at least 50% marks in the subject applied for admission and 45% marks in aggregate in case of the candidates of General Programme or equivalent grade point. Candidates passed the qualifying examination in CBCS must have studied minimum 24 Credits in the subject applied for admission.

3.	<b>Master of Commerce (M.Com.):</b> <b>(i) Finance and (ii) Marketing</b>	Bachelor's Degree with Major/ Speciality/ Honours in the concerned subject securing at least 45% marks or equivalent grade point. OR Bachelor's Degree with at least 50% marks in the subject applied for admission and 45% marks in aggregate in case of the candidates of General Programme or equivalent grade point. Candidates passed the qualifying examination in CBCS must have studied minimum 24 Credits in the subject applied for admission.
4.	<b>M.Sc. in Biotechnology and Bioinformatics</b>	Candidates with a Bachelor degree from a recognized University/Institution in Biological Sciences/ Agricultural Sciences/ Veterinary Sciences/Pharmaceutical Sciences/Medical Sciences with minimum 50% marks in aggregate or equivalent grade point.
5.	<b>M.A. in Mass Communication</b>	Bachelor's Degree in any discipline from a recognized University with minimum 45% in Major/ Honours or aggregate or equivalent grade point.
6.	<b>M.A. in Women's Studies</b>	Bachelor's Degree in any discipline from a recognized University with minimum 45% in Major/ Honours or aggregate or equivalent grade point.
7.	<b>M.A. in Applied Psychology</b>	Candidates having <b>Bachelor's degree</b> ( <i>excluding Fine Arts</i> ), including a Medical degree, and other Technical Graduates from Dibrugarh University or any other University recognized by the UGC with at least 45% marks in Major/ Honours or 50% marks in aggregate or equivalent grade point.
8.	<b>M.Ed. (recognized by NCTE)</b>	Obtained at least 50% marks or an equivalent grade in the following programmes: (i) B.Ed., (ii) B.A. B.Ed., B.Sc. B.Ed. (Integrated), (iii) B.El.Ed, (iv) D.El.Ed. with an undergraduate degree (with 50% marks in each)

\*Besides the above-

- a. Candidates appeared/ appearing in the 6<sup>th</sup> Semester B.A., B.Sc., B. Com Examinations, 2023 and waiting for their results are eligible to appear in the DUPGET 2023 and can get provisional admission if selected.
- b. Candidates appeared/ appearing in the Final Semester Examinations and waiting for results but have backlog in 2<sup>nd</sup> and/or 4<sup>th</sup> Semester Examinations are also eligible to appear in the DUPGET 2023 and can get provisional admission if selected.

\*However, the above mentioned candidates shall have to submit the Final Marksheet within a stipulated date to be decided by the University.

### 1. Conduct of DUPGET, 2023 for Selection of Candidates

- a) The DUPGET 2023 is conducted by the Dibrugarh University Post Graduate Entrance Test (DUPGET) Board, Dibrugarh University.
- b) The DUPGET 2023 shall be conducted for all candidates for the academic programmes mentioned below irrespective of the University they have passed the qualifying examination. The Subjects are-

**MA. in:** Anthropology, Assamese, Bodo, Economics, History, Sociology, Statistics, Geography, Education, English, Mathematics, Political Science, Philosophy, Applied Psychology, Mass Communication, Women's Studies

**M.Sc. in:** Anthropology, Applied Geology, Life Sciences (Zoology), Life Sciences (Botany), Physics, Statistics, Geography, Chemistry, Mathematics, Biotechnology and Bioinformatics

**M.Com. in** (i) Finance and (ii) Marketing

**M.Ed.**

*Notification for some other Post Graduate, Under Graduate, Diploma and Certificate Programmes have already been notified or will be notified separately.*

## **2. Selection Criteria for Admission through DUPGET 2023:**

- a) For the 80% of seats reserved for the students graduated from Dibrugarh University, ***shall be selected on the merit of the DUPGET 2023 (i.e. the weightage of DUPGET 2023 shall be of 100%)*** in addition to the fulfillment of minimum eligibility criteria.
- b) For the 20% of the seats reserved for the graduates of all recognized Universities other than Dibrugarh University, the ***candidates shall also be selected on the merit of the DUPGET 2023*** only subject to the fulfillment of minimum eligibility criteria.
- c) A Candidate is eligible to appear in the DUPGET 2023 in maximum 4 (four) subjects. Moreover, they should not apply in ***more than 1 (one) subject*** from the same Shift as given below-

**Shift 1:** Anthropology, Chemistry, Education, English, Mathematics, Applied Geology, History

**Shift 2:** Assamese, Biotechnology and Bioinformatics, Philosophy, Political Science, Bodo

**Shift 3:** Applied Psychology, Economics, Life Sciences (Zoology), Life Sciences (Botany), Physics, Statistics, Geography, M.Ed.

**Shift 4:** Sociology, Mass Comm, M.Com. in (i) Finance and (ii) Marketing, Women's Studies

**3. Nature of the DUPGET:**

- a) The DUPGET shall be of 100 Marks and of 2 (two) hours duration.
- b) It shall be conducted in a single paper of the concerned subject containing 100 Objective Type Multiple Choice questions (MCQ) carrying 1 (one) mark each.
- c) The Question Paper shall be in English excluding the language subjects.
- d) There shall be a provision of negative marking of 0.25 (point two five) mark for incorrect response to a question.
- e) The candidate shall be required to appear the DUPGET in the OMR Sheet and the evaluation process shall be done by the automated electronically operated system.
- f) The DUPGET score shall be valid for admission in the current academic session 2023-2024 only.
- g) *For any other details regarding DUPGET, 2023, please see the relevant Ordinance (Annexure-A).*

- c) The Candidates shall select their Test Centres while applying online for appearing in the DUPGET 2023. **Change of Test Centre shall not be allowed after final submission of the online applications.**
- d) *The Venues of the Test Centres shall be notified later on. Candidates are advised to visit the Dibrugarh University website frequently to get their Test venues.*

iii. *How to Apply:*

1. Application for appearing in the DUPGET 2023 shall be through online mode only. No other means of application shall be accepted.
2. Online Registration for submission of Application Form will begin from **23.05.2023**. Application for DUPGET 2023 is through online mode only. The last date for submission of application is **05.06.2023 (till 11.55 p.m.)**
3. For submission of the **Online Application Form**, intending candidates are advised to follow the following instructions:
  - a) The candidate shall be required to visit the DUPGET 2023 Portal in the website- [www.dibru.ac.in](http://www.dibru.ac.in).
  - b) The Candidate needs to register on the portal by clicking the “Register” button and providing his/her name, mobile number and a password. The mobile number will be verified through an OTP. Please remember the password for login.
  - c) After successful registration, the candidate needs to login using his/her mobile number and the password.
  - d) After login, the candidate needs to click on the “Apply” button corresponding to the link of “DUPGET 2023” which will lead to an application form. **The candidate needs to fill up the application form step by step.**
  - e) After filling-up the Form, Candidate needs to click the button “Submit and Review”. A preview of the filled-up form will be displayed. Candidates are advised to carefully cross-check the information and if anything needs to be corrected at this stage, they can go back and edit.

- f) After ensuring that all the information displayed on the Preview is correct, the candidate needs to click ‘**Pay now & Submit the application**’ and the pay the application fee of **Rs 750/- (Seven Hundred Fifty)** only through online mode (Debit Card/Credit Card/Internet Banking).
- g) The application form will be considered finally submitted only when the application fee is successfully paid by the candidate and an online receipt is generated confirming the payment.
- h) There will be a button to download the Application Form and Admit Card for future reference.
- i) The Candidate shall have to take a print out of the Admit Card and bring the same to the Examination Hall on the Date of the Test for verification.***
- j) The Submission of Online Application Forms shall be automatically closed after the last date.

**Important Note:** *The University shall not verify the eligibility of a candidate at the time of receiving their Application Forms and Issuing Admit Cards to them. The candidates not fulfilling the minimum eligibility may appear in the DUPGET, 2023. However, their candidature shall not be considered at the time of admission to the concerned Post Graduate Programmes conducted by Dibrugarh University and its affiliated colleges.*

**iv. Selection procedure:**

- a. 80% of the total seats in each subject under M.A./M.Sc./ M.Com. Programmes are reserved for the graduates of the affiliated/ permitted/ autonomous colleges/ institutes of Dibrugarh University.
- b. Remaining 20% of seats shall be filled up by the eligible candidates belonging to all recognized Universities **excluding** Dibrugarh University.
- c. For all candidates, appearing in DUPGET 2023 is mandatory.**
- d. The Candidates securing marks in the DUPGET 2023 in higher order shall get preference to take admission in to the relevant Programme in Dibrugarh University and in the Affiliated/ Autonomous Colleges according to their preferences.
- e. As the Selection of Eligible Candidates for admission to the Post Graduate Programmes shall be done only on the basis the DUPGET, 2023, the selection and admission shall be purely provisional and subject to production of relevant documents of passing the qualifying examinations with requisite norms before the concerned Department/ Centre for Studies/ College where he/ she has taken admission. An Undertaking shall also be taken from the admitted students in this regard.
- f. Statutory Reservation and Relaxation Policy shall be followed as per the Government Rules by the University and its Affiliated/ Autonomous Colleges while preparing the Merit List of the Candidates. In case of Academic Programmes conducted by the Teaching Departments/ Centres for Studies, the Dibrugarh University **Reservation and Relaxation Rules for Admission into Post Graduate, Under Graduate, Advanced Post Graduate Diploma, Post Graduate Diploma, Diploma and Certificate Programmes (Revised upto February 2022)** shall be applicable in selecting the eligible candidates under different non-statutory reservation categories.

v. ***Information for the Candidates Applying for Seats under Non-Statutory Reservation Quota\*:***

The candidates seeking admission under the Non-Statutory Reservation Quota in the categories-

**(i) Sons and Daughters of the DU Employees/Retired Employees, (ii) Sports, (iii) Art/Culture, (iv) Literary (v) NCC, (vi) NSS, (vii) Tea and Ex-tea Community, (viii) Local Gaon Panchayat, (ix) Moran and Matak Community, etc.** shall have to submit a print out of the Submitted Online Application Form of the DUPGET 2023 along with the self-attested copies of all relevant testimonials and a Filled-in Prescribed Form on or before **20.06.2023 by 4.00 pm** at the Office of the Deputy Registrar (Academic) Dibrugarh University. The Prescribed Form is given with this Notification.

***The Candidates seeking admission under (i) Differently Abled and (ii) Economically Weaker Sections (EWS) categories shall have to submit their documents at the Office of the concerned Teaching Department or Centre for Studies by 20.06.2023 along with a print copy of the Online Admission Form of DUPGET 2023.***

vi. ***Admission procedure and Schedule:***

1. Admissions to all Departments/ Centres of Studies shall be held separately. The Schedule and Procedure for admission shall be notified in the **website: *dibru.ac.in*** along with the List of the Provisionally Selected Candidates prepared by the Admission Committee of the Department/ Centre of Studies concerned.
2. ***The Affiliated and Autonomous Colleges shall announce their own Admission Schedule according to their convenience.***
3. The admission and other fees to be paid at the time admission shall be received through online payment system. The University shall guide the candidates for payment of their fees.



**DIBRUGARH UNIVERSITY ORDINANCE FOR CONDUCT OF ENTRANCE TEST FOR ADMISSION TO THE VARIOUS POSTGRADUATE PROGRAMMES**

**OF DIBRUGARH UNIVERSITY, 2019 (Amended upto date) (Notified vide Memo**

**No. DU/RG/G.01.01/20/4062 dated 20.10.2020)**

**4. Title:**

This Ordinance shall be called the ‘Dibrugarh University Ordinance for conduct of Entrance Test for Admission to the various Post Graduate Programmes of Dibrugarh University, 2019’ (Amended in October, 2020). This Ordinance shall come into effect from the academic session 2020-2021.

**5. Definition:**

‘Department’ means a department of the University and designated as such by it, with reference to a subject or group of subjects of study in the University {clause 2 (7) of the Dibrugarh University Act }.

- a) Centres for Studies shall mean a Centre established by the Executive Council, Dibrugarh University, on recommendation of the Post Graduate Board or Under Graduate Board and the Academic Council for conduct of Post Graduate/ Under Graduate Programmes (courses) and/ or research in a relevant field (The Dibrugarh University Ordinance for Centre for Studies, 2006).
- b) Colleges shall mean the Affiliated Colleges and Autonomous Colleges of Dibrugarh University offering the Post Graduate Academic Programmes.
- c) Entrance Test means the Examination conducted by the University to select eligible candidates for admission to the various Post Graduate Academic Programmes conducted by the Departments, Centres for Studies of Dibrugarh University and the Affiliated Colleges and Autonomous Colleges of Dibrugarh University as per the provisions of this Ordinance.
- d) The Entrance Test shall be called Dibrugarh University Post Graduate Entrance Test, hereinafter shall be called as DUPGET.

**6. Objectives:**

- e) This Ordinance has been framed to regulate the procedure for admission to the various Post Graduate Programmes of Dibrugarh University conducted by the Departments, Centres for Studies and the Affiliated Colleges and Autonomous Colleges of Dibrugarh University.
- f) This Ordinance is framed to streamline the Admission Procedure of the various Academic Programmes as envisaged by the guidelines of the UGC.

**7. Extent of Application:**

- g) This Ordinance shall be applicable to the admission to the following Academic Programmes conducted by the Departments, Centres for Studies and the Affiliated Colleges and Autonomous Colleges of Dibrugarh University:

**MA in:** Anthropology, Assamese, Bodo, Economics, History, Sociology, Statistics, Geography, Education, English, Mathematics, Political Science, Philosophy, App. Psychology, Health, Hygiene and Sanitation, Mass Communication, Women Studies.

**M.Sc. in:** Anthropology, Applied Geology, Life Sciences, Physics, Statistics, Geography, Chemistry, Mathematics, Biotechnology & Bio-informatics.

**M.Com. in** (i) Finance and (ii) Marketing

**M.Sc. Tech. in Applied Geophysics**

**M.Ed.**

Separate Entrance/ Admission Procedure will be adopted for other Post Graduate Academic Programmes like M.Tech, MA in Performing Arts, M.Lib.I.Sc. MSW, MCA, etc.

- h) This Ordinance shall comply with the existing Dibrugarh University Reservation and Relaxation Rules (as amended upto date) given in Annexure I in case of the Post Graduate Programmes conducted by the Teaching Departments and Centres for Studies of the University.

#### **8. Selection of Candidates:**

- c) The DUPGET shall be conducted for all candidates of all the academic programmes mentioned in clause 4(a) irrespective of the University they have passed the qualifying examination.
- d) For the 80% of seats reserved for the students graduated from Dibrugarh University, shall be selected on the merit of the DUPGET, 2020 (i.e. the weightage of DUPGET 2020 shall be of 100%) in addition to the fulfillment of minimum eligibility criteria.
- e) For the 20% of the seats shall be reserved for the candidates other than Dibrugarh University, the candidates shall also be selected on the merit of the DUPGET only subject to fulfillment of minimum eligibility criteria. However, if the seats remain vacant, the same be filled up by the Dibrugarh University candidates

**9. Conduct of DUPGET and Functions of the DUPGET Board:**

- a) The DUPGET shall be conducted by the Dibrugarh University Post Graduate Entrance Test (DUPGET) Board constituted by the Vice-Chancellor from time to time. It shall consist of a Chairperson, a Member-Secretary and five Executive Members. Besides the above, the Registrar and the Controller of Examinations shall be ex-officio members of the Board. The duration of the DUPGET Board shall be of 3 (three) years.
- b) The DUPGET Board shall take necessary action for conducting the DUPGET with approval from the University.
- c) The DUPGET Board shall recommend the schedule, budget and all other relevant aspects for smooth conduct of the Test.
- d) The Chairperson and Member-Secretary shall appoint the persons for different confidential and administrative assignments like question paper setter, evaluator, observer, etc. from the panel of the same approved by the Vice-Chancellor.
- e) The DUPGET Board shall extend necessary support to the Departments and Centres for Studies in the admission process as and when necessary.
- f) The DUPGET shall be normally held in the second/ third week of June every year as per the schedule notified by the University from time to time. In special circumstances, the schedule may be changed.

**10. Notification of the DUPGET:**

- a) The candidates appearing the final semester examinations or have cleared the relevant qualifying examinations are eligible to appear in the DUPGET.
- b) The intending candidates shall have to apply online for appearing the DUPGET with a payment of a prescribed fee as per the notification of the University, which will be issued in the first week of May every year.
- c) On recommendation of the DUPGET Board, the Registrar/ Deputy Registrar (Academic) shall issue the Notification of the DUPGET and Admission to the Post Graduate Academic Programmes.

**11. Nature of the DUPGET:**

- h) The DUPGET shall be of 100 Marks and of 2 (two) hours duration.
- i) It shall be conducted in a single paper of the concerned subject containing 100 Objective Type Multiple Choice questions carrying 1 (one) mark each.
- j) The Question Paper shall be in English excluding the language subjects.
- k) There shall be a provision of negative marking of .25 mark for incorrect response to a question.

- l) The candidate shall be required to appear the DUPGET in the OMR Sheet and the evaluation process shall be done by the automated electronically operated system.
- m) The DUPGET score shall be valid for admission in the current academic session only.

**12. General:**

- a) In the Process of its execution, keeping the spirit intact, the DUPGET Board may reinterpret the clauses of the Ordinances as and when necessary.
- b) For any matter not covered under this Ordinance, the existing University Rules, Ordinances, Statutes and the Dibrugarh University Act, 1965 (as amended) shall be applicable.
